EDUCATION FUNDING REFORM: SB 1

- Overhauls Illinois' worst-in-the nation school funding formula
- Under SB 1, no school district would receive less funding than it received this past year.
- Implements an evidence-based model for school funding, which accounts for factors such as students with disabilities, English language learners and low-income students.
- Provides additional support for the needlest districts in the guest for adequate funding.
- High-tax school districts are eligible for property tax relief.
- Passed on May 31.

GOVERNMENT CONSOLIDATION: SB 3

- Allows counties to dissolve duplicative local governments by referendum.
- Extends local government consolidation procedures that exist in DuPage, Lake and McHenry counties to the entire state.
- Expected to save taxpayers more than \$100 million over the next 20 years.
- Passed on May 31.

PROPERTY TAX RELIEF: SB 482 and 484

- Implements a two-year freeze on property taxes for local governmental bodies.
- Qualified school districts are able to apply for a financial hardship waiver.
- Passed the Senate on May 30.

REFORMS PASSED BY THE SENATE

WORKERS' COMPENSATION REFORM: HB 2525

- Maximizes efficiencies in Illinois' workers' compensation system while retaining the basic set of protections Illinois workers have benefited from for more than 100 years.
- Strives to pass savings onto employers by increased regulations for insurance companies
- Creates an evidence-based prescription drug formulary.
- Reflects recommendations from the governor, including controlling money spent on prescription drugs and clarifying the use of AMA guidelines.
- Passed on May 31.

PENSION REFORM: SB 42

- Implements a third tier of pensions for new hires that is similar to a 401(k).
- Estimated to save the state \$1.5 billion.
- Tier 2 employees may elect to receive Tier 3 benefits.
- Shifts pension responsibility for employees that make more than the governor to employers.
- · Passed on July 4.

TERM LIMITS: SR 3

- Limits the Senate President and the Senate Minority Leader to five terms, lasting a maximum of 10 years.
- Adopted Jan. 11.

PURCHASING REFORM: SB 8

- Eliminate barriers to vendor participation.
- Creates cost savings through more efficient procurement practices.
- Includes provisions negotiated with the governor's office, the state's chief procurement officers, universities, the Illinois Chamber of Commerce and other business groups.
- Estimated to save the state \$70 million.
- Passed on May 31.
